## AustSafe Travel and Training Bursary

The Future Farmers Network (FFN) aims to build the industry engagement and networks of young people in agriculture. FFN offers our Members Travel and Training Bursaries to assist members with the cost of attending additional skilled training, certification training, industry or commodity based events.

Bursaries will be provided up to the value of \$2,000 with additional funds being administered at the FFN Board's discretion. To be eligible all applications must address the specified criteria. ### **BURSARY CRITERIA:**

1. Applicant must be a financial FFN member and have held membership for a minimum of 3 months prior to application date;
2. Application must demonstrate how attending the bursary event will add to his/her knowledge, industry engagement & broadening of networks;
3. Applicant must provide evidence of attendance costs including but not limited to course flyers, copy of receipts/conference registrations, estimated kilometres to be travelled (distance travelled in own vehicle will be reimbursed on a \$0.66/km basis); and
4. Applicant must have fully met the above criteria and completed the below documentation to be considered for a bursary.
